Ohrid fair for social entrepreneurship was organized with the assitance of the regional centre from Ohrid, with the presence of various stakeholders and a workshop on public procurement, with the EPTISA expeerts. talked to the Mayor of Vevcani to explore the possibilities of future cooperation. The mayor of Krobia used the opportunity to invite the Vevcani mayor to be a part of the coming study visit and to see how the Polish municipalities practically implement social entrepreneurship in their municipalities, forming social enterprises.
DAY 4, Bitola & Veles visits	The final day was used for visiting the mayors of Bitola and Veles, including their local social enterprises and regional centres' representatives, who eagarily listened to the stories of the Polish representatives of the municipalities of Krobia and Roketnica and the social enterprises who informed the Macedonian colleagues that, despite some challenges, it is possible to start social entrepreneurship initiatives.
